Del de Windt Leadership Award for Civic Engagement 2024 Recipients

Fred & Brittan DiSanto



Fred and Brittan DiSanto are dedicated philanthropists and community leaders, passionate Cleveland sports fans, and avid golfers. Their generosity to their alma maters has enabled the commencement of transformational projects for the student experience particularly in the visual arts, with recent gifts to Case Western Reserve University, St. Ignatius High School, and Magnificat High School.

Fred is the Chairman and Chief Executive Officer of Ancora, a private wealth advisor and institutional asset manager with nearly \$10 billion of assets under management. Fred is the Chair of the Board of Trustees at Case Western Reserve University, a Trustee and former Chair of the Board of the Greater Cleveland Sports Commission, and former Chair of the Board of Regents at St. Ignatius High School. Fred also serves as a Director at Medical Mutual, Ampco-Pittsburgh, The Eastern Company, and Regional Brands, Inc.

An arts professional and a teacher, Brittan has a significant passion for the visual arts, which is evident in the projects funded by the DiSantos. At Magnificat, their gift will transform the existing visual arts wing creating an open and inviting learning environment fostering creativity, collaboration, and interdisciplinary learning. At St. Ignatius, their gift supports the Campaign for Vision '30 and used to fund a new three-story academic wing, which will house a world-class Visual Arts department with multiple studios.

Congrats also to Fred and Brittan on winning the 2024 men's and ladies' club championships at The Pepper Pike Club and Canterbury Golf Club, respectively!

The award recognizes outstanding members of the Cleveland community who exemplify the values and spirit of community service and civic engagement that Del de Windt represented throughout his life. Mr. de Windt was Eaton Corporation's chairman of the board and CEO (1969-1986). His retirement in 1986 culminated a 45-year association with the company.
